Lift Tickets: Coaches: Complementary per IMD rules.
Racers: \$32 - Vouchers for racer tickets will be given to coaches at the team captains meeting and can be used at any ticket window.
Parents: \$59 - Parents can get vouchers at race HQ each morning from 8-9am.

Race Hill: Sunrise Run (accessed from Orange Bubble Express, **mid-station**).
The finish area is accessible by walking.

Plaques for overall top male & female, 2-day combined total.

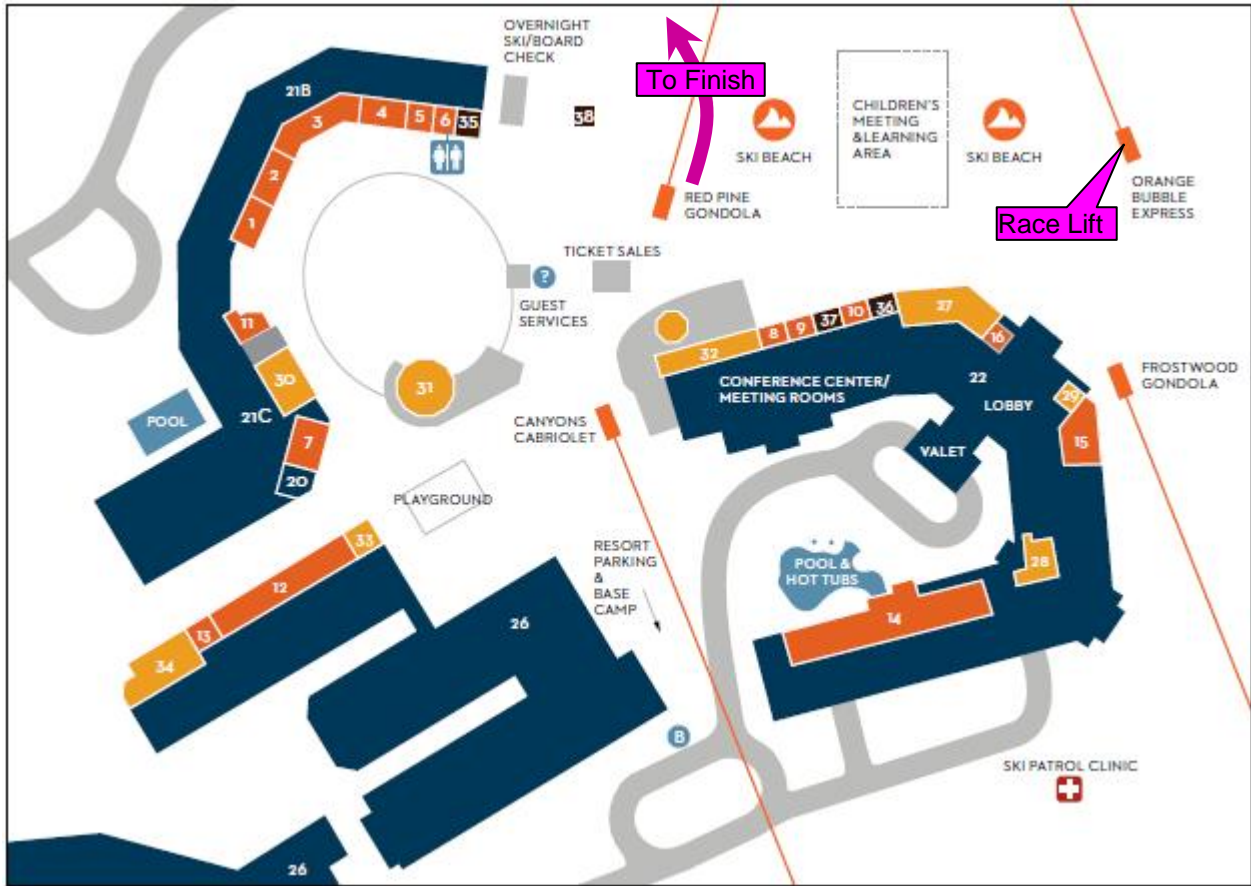

EVENT PARTICIPATION HOLD HARMLESS, RELEASE OF LIABILITY AND INDEMNITY AGREEMENT

In consideration for being allowed to participate in the Summit Slaloms Ski Race, I, the "Participant", ("THE UNDERSIGNED" means only the PARTICIPANT when the PARTICIPANT is age 18 or older OR it means both the PARTICIPANT and the PARTICIPANT'S parent or legal guardian when the PARTICIPANT is under the age of 18.) _____ understand, agree to and except the following:

PARTICIPANT agrees and understands that assisting with preparation of the Event, taking part in the Event and/or any other uses of the ski area facilities (hereinafter the "Event") can be **HAZARDOUS and may involve the risk of serious physical injury or death.**

In consideration of allowing the Participant to participate in the EVENT, THE UNDERSIGNED hereby agree to **ASSUME ALL RISKS** associated with the PARTICIPANT's participation in the EVENT. Additionally, THE UNDERSIGNED agree to **HOLD HARMLESS, RELEASE, DEFEND, AND INDEMNIFY**, ASC Utah dba The Canyons, its affiliated organizations and companies, and its insurance carriers, parent, agents, employees, representatives, assignees, officers, directors, and shareholders (each hereinafter a "RELEASED PARTY") for **ANY AND ALL LIABILITY** and/or claims for injury or death to persons or damage to property arising from the PARTICIPANT's participation in the EVENT, **including those claims based on any RELEASED PARTY's alleged or actual NEGLIGENCE OR BREACH OF any express or implied WARRANTY.** The UNDERSIGNED understands and agrees that The Canyons is providing access to its terrain in exchange for their acceptance and acknowledgement of full liability and responsibility for an injury, death or damage caused by or to Participant or arising out of his/her use of The Canyons by them.

THE UNDERSIGNED further agree and understand that risks associated with the EVENT, in addition to those previously listed, include, but are not limited to: equipment malfunction; surface conditions; marked and unmarked obstacles; rugged mountainous terrain; slick or uneven riding and walking surfaces, surfaces covered with ice and snow; strenuous activity; high elevation; falling; avalanches; cornices suffocation; sharing ski area facilities and EVENT venues with people directly involved and/or not directly involved in the EVENT. PARTICIPANT understands and acknowledges he/she has been informed and understands all rules and regulations of participating in the EVENT. PARTICIPANT is responsible for reading, understanding and complying with all signage, including instructions on the use of the lifts. PARTICIPANT recognizes that he/she must have the physical dexterity and knowledge sufficient to safely load, ride and unload the lifts. PARTICIPANT assumes the risk of riding the lifts and engaging in activities accessible from the lifts and understands that **he/she may have to ride the ski lifts without an adult present.** PARTICIPANT understands that snowmobiles, snowmaking, snow-grooming and EVENT preparation equipment may be encountered at any time. PARTICIPANT recognizes that falls and collisions occur and injuries are a common and ordinary occurrence of the EVENT. **Despite all these risks, Participant voluntarily chooses to take part in the Event.**

If participating in a competition PARTICIPANT understands that he/she may take the opportunity to inspect the venue prior to participation. **PARTICIPANT understand that the use of helmets is strongly recommended and inverted aerials are prohibited.**

In consideration for allowing the PARTICIPANT to participate in the EVENT and for using the ski area facilities, THE UNDERSIGNED agree that **ANY AND ALL CLAIMS** for injury and/or death arising from the PARTICIPANT's participation in the EVENT shall be **GOVERNED BY UTAH LAW** and **EXCLUSIVE JURISDICTION** of any claim shall be in the **DISTRICT COURT residing where the alleged incident occurred or in the FEDERAL COURT FOR THE STATE OF UTAH.** Recognizing the risk and dangers, the undersigned understand the nature of the activity and voluntarily choose for participant to participate in and expressly assume all risks and dangers of the activity, whether or not described above, known or unknown, inherent or otherwise.

In the case of a minor PARTICIPANT, the undersigned parent or legal guardian acknowledges that he/she is also signing this release on behalf of the minor PARTICIPANT and that the minor PARTICIPANT shall be bound by all the terms of this release. Additionally, **by signing this release as the parent or legal guardian of a minor PARTICIPANT, the parent or legal guardian understands that he/she is waiving certain rights on behalf of the minor that the minor otherwise may have.** The undersigned parent or legal guardian agrees that but for the foregoing, the minor would not be permitted to participate in the EVENT. The undersigned parent or legal guardian also agrees that if the PARTICIPANT is injured, the parent or legal guardian authorizes medical care for the PARTICIPANT and/or transport of the PARTICIPANT to a medical facility at the parent/legal guardian's expense. No provision in this Release shall create a duty to provide medical care or transportation to any PARTICIPANT. The furnishing of medical care is neither an admission nor an assumption of liability by the Released Parties.

By signing this release without a parent or guardian's signature, the PARTICIPANT represents that he/she is at least 18 years of age, or, if signing as the parent or guardian of the PARTICIPANT, represents that he/she is the parent or legal guardian of the minor PARTICIPANT.

THE UNDERSIGNED agree and understand that this Liability Release is applicable to each and every day PARTICIPANT participates in the EVENT.
