ALPINE RELEASE & WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT ("Agreement")

In consideration of myself OR my child being permitted to participate in any way in the alpine ski school/club activities ("Activities") of the above Alpine Ski School/Club, **I represent that I do**, on behalf of myself OR my child:

1. **I acknowledge** agree and represent **I fully understand** the nature of alpine skiing/snowboarding and alpine ski school/club activities, and that **I am** and my child (if applies) is **qualified**, in good health, and in proper physical condition to participate in such Activities.
2. **I fully understand** that (a) Alpine skiing/snowboarding and Alpine Ski School/Club activities **involve inherent risks** and dangers of serious injury, and or death, (b) these risks and dangers **may be caused** by my own (or my child's) actions or inactions or omission, intentional or otherwise, or the actions or inactions of others participating in the Activities and/or the **condition** of which Activities take place.
3. **I hereby agree** for myself and for my child (if applies), **to release**, discharge, indemnify and covenant **not to sue**, the above listed Alpine Ski School/Club or its parent organization, its respective administrators, directors, agents, officers, members, volunteers, and employees, any sponsors, advertisers, and, if applicable, owners and lessors of the premises of property on which the Activities take place (each considered one of the "Releasees" herein), **from all liability** claims, demands, losses or damages on my account caused or alleged to be caused in whole or in part by the "Releasees" or otherwise
4. **I fully accept and assume** all such risks and all responsibilities for losses, costs, and damages, I incur as a result of my participation in the Activities. My signature signifies that **I fully understand and agree to be bound by** this Release and Waiver Agreement, for myself and for my underage child (if applicable), and agree that if any portion of this agreement is held to be invalid, the balance, notwithstanding, shall continue in full force and effect.

RELEASE OF LIABILITY AND INDEMNITY AGREEMENT**

In consideration for my participation in the IMD Spring Fling Ski Race
at Grand Targhee Resort, I understand, acknowledge and agree as follows:

1. I understand that **skiling, snowboarding, and participating in any training, competitions, special events, or other activities at Grand Targhee Resort ("GTR") can be dangerous. I further understand that there are inherent and other risks and dangers associated with these activities, which may be known and unknown, and which include, but are not limited to, variations in terrain; existing and changing snow conditions; deep snow; avalanches; slick or uneven walking surfaces; surfaces covered with ice and snow; changing weather conditions; difficulty with route finding; high altitude; ski lift, mechanical and equipment failures; rocks; stumps; trees; tree wells; cliffs; streams; closed areas; other participants and spectators; collisions with others; collisions with natural and man-made objects and features which may or may not be marked; and the set-up, use of, and tear down of training courses and features. I acknowledge that snowmaking and grooming activities and equipment, and snowmobiles may be encountered at any time. I recognize that falls and collisions occur and injuries are a common and ordinary occurrence of the above activities, and I understand that accidents, injury, illness, incapacity or death can arise in conjunction with participating in the above activities. In consideration for participating in any activities at GTR, I hereby freely and expressly agree to accept and assume any and all risks in connection with such activities. I ACKNOWLEDGE THAT IT IS MY RESPONSIBILITY TO INSPECT THE COURSE AND/OR FEATURES PRIOR TO ANY COMPETITION, INCLUDING PRACTICE RUNS. I ALSO UNDERSTAND THAT HELMETS ARE REQUIRED.**
2. I further agree to forever release, discharge, waive, save and hold harmless, indemnify, and defend Grand Targhee Resort, LLC, GLT Holdings, LLC, their owners, subsidiaries and/or affiliates, their officers, directors, shareholders, employees, agents, the U.S. Forest Service and all other applicable landowners, sponsors and insurance carriers (hereinafter "Releasees") from and against any and all claims, demands, causes of action, liabilities, actions, and any and all medical expenses or other related expenses, including damage to property, asserted by others, by me, or on my behalf, my estate, executors, heirs, or assigns brought under any theory of legal liability, INCLUDING ORDINARY NEGLIGENCE, arising directly or indirectly out of my use of the facilities, ski area or ski lifts at GTR, or my presence on GTR premises. The above release includes, but is not limited to, any and all damages occasioned in the event of an incident, illness, or other incapacity, death, or damage to property, however caused. I understand and agree that this release is applicable to each and every day I participate in any activity at GTR. If I want financial protection against personal injuries, I understand that I must obtain my own life, liability and health insurance to protect my family members and myself.
3. I consent to the use of any pictures of me for commercial purposes, or otherwise, in connection with any activity at GTR.
4. I warrant that I am in good physical condition and know of no medical or health reasons why I should not participate in any of the above activities. I authorize GTR to transport me or arrange for my transportation to a medical facility should I become incapacitated and unable to make an informed decision. I agree that upon such transport, Releasees shall have no responsibility for me and I agree to indemnify and hold harmless Releasees from any costs incurred and any claims originating therefrom.
5. I understand that this agreement shall be binding upon my heirs, executors, administrators, and assigns and shall be governed by Wyoming law. This agreement shall be binding to the fullest extent permitted by law. I also understand that if any part of this agreement is determined to be unenforceable, all other parts shall be given full force and effect. I agree that any claims that I may bring against the Releasees shall be submitted to the jurisdiction of the state court in Wyoming, Teton County, and that no claims against the Releasees shall be brought in any other jurisdiction or venue.
6. I further state that I am of lawful age and legally competent and agree to abide by the terms and conditions set forth herein. I understand that the terms of this document are contractual and not a mere recital. I am aware that I am releasing certain legal rights that I otherwise may have and I have signed this document as my own free act.
