**Release and Waiver of Claims**

In consideration of being allowed to participate in the IMD North Series GS's (the "Race Event") hosted by McCall Winter Sports Club (the "Team") and operated by Brundage Mountain Resort Co.(the "Facility"), the Participant, and the Participant's parent(s) or legal guardian(s) if the Participant is a minor, do hereby agree, to the fullest extent permitted by law, as follows:

- 1) **TO WAIVE ALL CLAIMS** that they have or may have against the Team and Facility arising out of the Race Event.
- 2) **TO ASSUME ALL RISKS INHERENT IN participating in this Race Event, including Death.**
- 3) **TO RELEASE** the Team and the Facility, its owners, affiliates, officers, directors, employees, agents, and shareholders, from all liability for any loss, damage, injury, or expense that the Participant (or his/her next of kin) may suffer, arising out of the inherent risks of participation the Race Event.
- 4) I agree to defend, indemnify and hold harmless MWSC and Brundage for and from any injury to other person(s) or property which I may cause as a result of engaging in the Race Event.
- 5) I authorize Brundage and/or its authorized personnel to call for medical care for me or to transport me to a medical facility or hospital if, in the opinion of such personnel, medical attention is needed for me. I agree that, upon my transport to any such medical facility or hospital, Brundage shall not have any further responsibility for me. Further, I agree to pay all costs associated with such medical care and related transportation provided for me and shall defend, indemnify and hold harmless Brundage of and from any costs incurred herein.
- 6) I agree that any and all disputes between Brundage and me arising from my participation in the Race Event or my use of rented equipment, and including any claims for personal injury and/or death, will be governed by the laws of the State of Idaho and exclusive jurisdiction thereof will be in the district court residing in and for Valley County, Idaho.
- 7) In the event any section of this release is found to unenforceable, the remaining terms shall be fully enforceable.
- 8) This Release shall be binding to the fullest extent permitted by law.
- 9) The Release shall be binding upon my assignees, heirs, next-of-kin, executors, personal representatives, administrators, and insurers, and may be pled by Brundage as a complete bar and defense against any claim, demand, action, or causes of action by me or on my behalf.

The Participant also acknowledges that this agreement does not, in any way, change the rights or obligations of the Facility or the Participant, other than as set forth in this agreement.
